<b>Background</b>
-------------------

California has the largest veteran population in the US, with almost two million veterans calling California home—a number that is expected to rise by over 200,000 when the wars in Afghanistan and Iraq wind down. California also has more homeless veterans than any other state, with 25 percent of homeless veterans in the nation residing in the state. To address this issue, Governor Edmund G. Brown, Jr. signed the Veterans Housing and Homeless Prevention Bond Act of 2014 by Speaker John A. Pérez (D-Los Angeles), giving California voters in June 2014 the opportunity to repurpose \$600 million in existing veterans’ bond funds to respond more effectively to the housing needs of today’s veteran population and their families.

In addition to providing better housing options for today’s diverse and expanding veteran population, the Measure backed by the California Association of Veteran Services Agencies and the Corporation for Supportive Housing, expands on proven and cost-effective supportive housing and service models that will reduce veterans’ homelessness, leverage public and private dollars, and decrease other public costs such as health care and incarceration expenditures. If voters approve of the initiative next year, California will be at the forefront of the nation’s efforts to end veteran homelessness by 2015.

#### **Brown Signs Bills to Aid Veterans (October 2013)**

“Brown, a Democrat, signed a veterans housing bill in a traditional Republican city with a large military presence (San Diego), ‘I know some folks in this part of the state are a little skeptical about what we do up there in the state Capitol,’ he said, surrounded by veterans and public officials. ‘But today, we’re doing something really good, and the people behind me are making it happen, for veterans, for families, for our future.’”

#### **Veterans Get Boost From Brown (October 2013)**

“‘This is California’s opportunity to lead the nation and demonstrate what other states can do to provide housing to homeless vets and their families,’ said Assemblyman John Perez, D-Los Angeles, who carried Assembly Bill 639 to put the issue before voters. Brown and Perez noted that the state’s existing bond authority for veterans’ housing has ballooned because of a lack of demand, yet thousands of other former members of the military are homeless or struggling to pay the rent. The money would be used to mostly work with nonprofit housing agencies.’”

#### **Governor Signs Bill to Help Homeless Veterans (October 2013)**

Assembly Bill 639, authored by Assembly Speaker John Perez (D-Los Angeles) would create veterans housing communities. These communities would also offer services, including mental health counseling, substance abuse treatment and job training. ‘We’ve all been to war and returned safely, but many of our comrades have not. They brought their war back home with them, and they’re still fighting for their lives,’ said Steve Peck, president of U.S. Vets and a Vietnam veteran himself.”

“The most significant state bill designed to help homeless veterans, AB 639, was pushed by Assembly speaker John Perez, who has been visiting hospitalized service personnel recently. The bill would fill in the gaps left by the original ballot measure. The bill is on the governor’s desk. Approval in both houses of the Legislature was almost unanimous. For reasons that should be obvious, the governor should sign it. Vets who served us and returned home to find that civilian life doesn’t necessarily guarantee a place to live deserve a better welcome.”



## **A Billion in Unspent Aid Isn’t Helping Homeless Vets (September 2013)**

“It’s a national embarrassment that so many of the military men and women who served in wars overseas come back and don’t have homes of their own or even places to sleep. California voters want to help veterans get decent homes, but their good intentions have fallen flat because of the government’s ineffectiveness...Brown should sign this bill (AB 639) now. Too many military men and women who have represented the United States in troubled times, in hostile situations and with families waiting back home, are in need of new beginnings. This would be the governor’s salute to them.”
